



Here at TCK, we only offer some of sires for outside breeding on a limited basis by private treaty; specific sires may have different requirements as notated below. We only offer stud service to approved registered bitches that meet all the requirements listed below. Bitch owner must contact TCK prior to any breeding for approval of said bitch before any terms will be discussed. Criteria for approval of said bitch includes, but is NOT limited to: Conformation, movement, temperament, pedigree & general health. If upon arrival of bitch at TCK we deem her unfit for breeding because of her physical or mental condition, you will be offered the option of dam substitution or time to correct the issue and return during her next cycle. Examples of unfit physically would be grossly overweight or underweight, signs of obvious injury or infection. Any bitch showing signs of aggression will be sent home and will not be allowed to return for breeding. We strongly believe that temperament is a vital part of breeding considerations.

- 1. One month before arrival at TCK for breeding, the bitch should have a thorough pre-breeding physical examination by a veterinarian. Her vaccinations should be current, and she should be tested and treated for parasites. She must also be tested for brucellosis, an infectious bacterial disease that can cause sterility or spontaneous abortion in affected dogs. Bitch owner must provide proof of this exam and testing. Records may be faxed directly to our veterinarian for review, and should include full exam notes and test results. Records will be checked for validity. Please note, you may be required to give your veterinarian permission to speak with myself or my veterinarian.
- 2. Bitches must be between two (2) and ten (10) years old. While AKC will register puppies from a bitch 8 months of age, we do not feel that Siberians are mentally or physically mature enough to breed until they are at least 2 years of age. AKC will also register pups from a bitch until 12 years old, however the older your bitch gets, the harder it can be on the dam and a greater risk to her health and safety. We will not breed a bitch that has delivered pups within 6 months of her previous litter.
- 3. Said bitch was not sold by her breeder on a "spay/neuter" contract, AKC Limited registration or any similar terms with any other registry.
- 4. A copy of her registration certificate, pedigree and a copy of her record of vaccination and worming are required for our records. You should bring the original certificate, we can make copies here. If you are unable or unwilling to bring the original, we will be contacting said registry to verify that the dog is currently under your ownership before any breeding takes place.
- 5. Two living puppies at 2 weeks of age constitute a litter. If there is one living puppy at 2 weeks, we will repeat the stud service for a fee of \$150.00.
- 6. If the bitch does not conceive on her first time here, we will repeat the stud service for free. Bitch owner responsible for any additional veterinary costs should she require a reproductive exam or culture. Veterinary fees to be paid directly to the veterinarian.
- 7. If the bitch does not conceive after two visits, and there has been at least one verified tie each visit, there will be no further repeat services and no money refunded. Stud fees are transferable to different bitches owned by the same person if arrangements are made with me prior to any stud service.
- 8. The bitch's owner is financially responsible for any accidental damage done to our property. Two separate estimates of any damage will be supplied to the owner of the bitch.
- 9. STUD FEE MUST ACCOMPANY all bitches on or prior to their arrival, unless other arrangements are made in advance. TCK retains the right to refuse to sign the litter registration application until the stud fee has been paid.
- 10. All pet quality puppies will be sold on a spay/neuter contract. No puppies will be sold to pet stores, puppy mills or brokers nor given to the Humane Society or dog pound.

Bitch shall only be bred to the sire indicated below.
